As your B2B payment experts, we are committed to continuing to help you submit quality transaction data that helps qualify for the best possible rates under the new program.

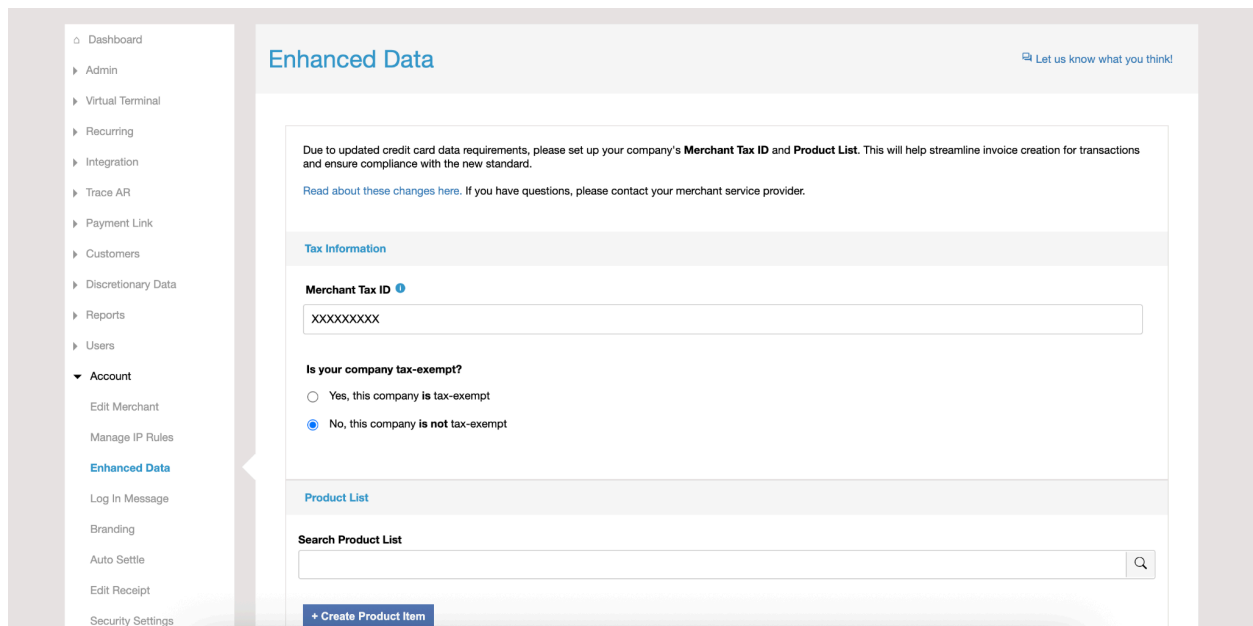
To help meet the new CEDP requirements, we are introducing our new PayTrace Product List feature, which will allow you to enter your full catalog of products. These custom product lists will help to submit detailed enhanced data with each transaction, and will allow Visa to verify that the information being submitted is accurate and of good quality.

This guide is your go-to resource for helping you set up your custom product lists in the Virtual Terminal.

Creating a Custom Product List

1. Log into the Virtual Terminal at <https://paytrace.com/login.pay>
2. Click "Account" in the menu on the left
3. Select "Enhanced Data"

In the "Add New Product" window, you can type in the name/label of your product, as well as the product code, commodity code, unit of measure, and cost per unit.

- **Product Label** - The product label should describe the product referenced in this line item record. This value should be unique.
- **Product Code** - The product code should be the identifier of this product within your accounting or product management system.
- **Commodity Code** - The commodity code should be the international description code of the overall goods or services being supplied.
- **Unit of Measure** - This is the unit of measure (i.e., gallons, pounds, liters, ounces, etc.) that is used to quantity each number/count in the quantity value.
- **Cost Per Unit** - The unit cost is the cost per quantity of the product/service referenced in this line item record.

Once you click "Save Product Item," the new product gets added at the bottom of the product list with the lowest priority number.

Search Functionality

The Search Product List area allows you to search for any product in your custom product list.

Type into the search box and click the magnifying glass or press enter to see your search results.

Note: The search functionality will search all fields of a product item. If you type in "ga," your results will include lines where the product label is "garbage bags" and also where the unit of measure is "gallons."

Edit/Delete a Product

Click the 3-dot menu on the right side of any product line item to edit or delete an existing product.

Click "Save Product Item" to save the changes made to the product.

Product Priority

The product list feature allows you to sort your products by priority. Your most frequently purchased items should be at the top of the list, ranging down to your least frequently purchased items.

You can select, and then drag a product up or down to create a new priority order for your products. Once a product has been moved, the priority number of that item will update accordingly.
